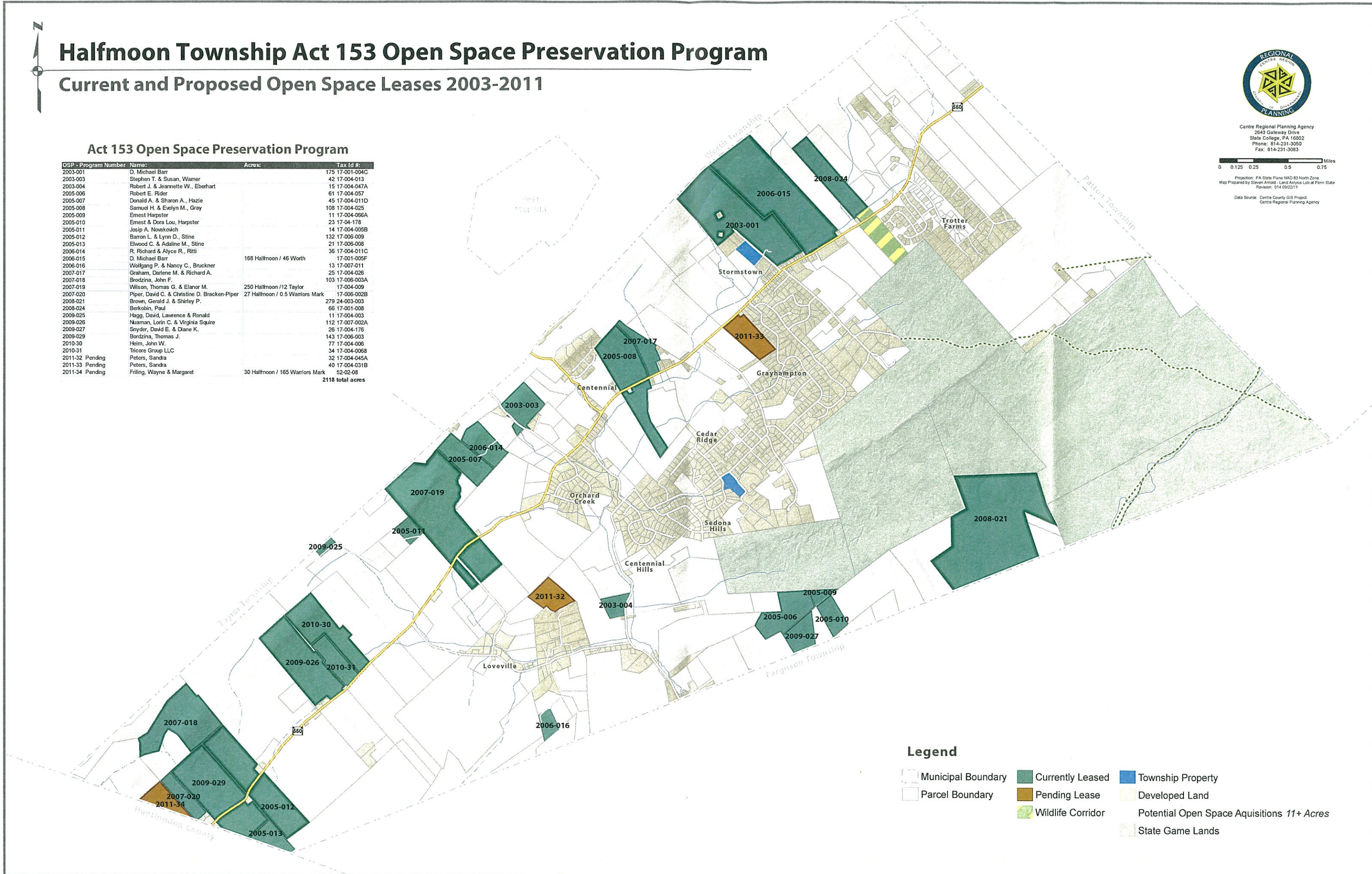


Projection: PA State Plane NAD 83 North Zone
